- OEM has been working closely with the IMT3; Liaison between the team and EOC. Looking for non-fire folks to help in the EOC so they do not compete for the same resources when an incident occurs.
  - o EOC working on improving their functional areas.
  - O Looking forward to working with the IMT and agencies on training opportunities.
