1. WERF Agreement -

 permitted to order directly through Fort Collins Fire Chiefs are not on the
 list of who can order. There needs to be clarity about who can order.
- Allen Owen will provide clarification about the wording in the WERF Agreement and will bring it to the July BCWFC Meeting and send details via email to the Cooperators.

2. Training levels:

- Engine boss standards in the County and the needs of the USFS and Boulder County IMT. Type 1 and 2 teams require NWCG Engine Boss standards. Type 3 events where you have requested the County to manage the event, ENOPS may be sufficient. Discussions with BCIMT ICs need to be engaged in this conversation.
- Engine operator designation (ENOPS, BLM task book) is this an agency certification? Task book is available squad boss and mechanical requirements are a part of this. ENOPS and Engine Boss designations are not inter-changeable. See attached task book.
