Treasurer's Report: We have \$8216.12 in the account, \$1738.24 in the EMS account.

EMS Committee: EMT refresher no cost this fall, EKG/12 lead in August, free, BRFR hosting, all classes available on BOCO fire. Looking into IO training materials for the cache. BRFR has 3 LP500 AEDs free to deserving agencies, please contact Claudia. Bret offered the EMS committee an opportunity to apply for a portion of the AMR \$10,000 EMS education grant as there are no applications yet. Contact Bret for applications.

DFPC: Both SEATS are on in Rifle; they come in tandem if available. P3 next week at Ft Love all aircraft suppressant on the first load, retardant after that unless you want suppressant, helicopters are on, three T3's in the area moving over to Wildland instead of all hazard. CRRFs are due by next week. IQS has a lot of holes, taskbooks are incomplete/expired, training missing, lack of experience, ensure 310-1 standards are followed, IQS folks should review their agency's IQS for accuracy. DFPC will help agencies clean up expired data, Tony is hoping to be available for site visits this winter to assist agencies w/IQS.

OEM: IPAWS introduced (Public Warning) smart phone push capabilities. Big Four planning effort handout looking to go front range incident management, also building front range resource management system, supported by the undersheriffs currently. Severe Weather Handbook has been updated/replaces the 4 Mile flood handbook. Public warning language updates coming out.

Cooperators: BOCO spring classes very successful, purchased AED and a floating pump, looking for 2-50' $\frac{3}{4}$ hoses and 3-1" nozzles. BOCO grant is submitted for \$12,000, looking to install a window prop at the FTC.

MCI: The consortium is working on their portion of the MCI plan in Operations.
