### Class is limited to 20 students

The purpose of the Instructor II/III course is to provide senior Instructors with the knowledge and skills to meet the minimum job performance requirements as outlined in NFPA 1041 through the Fire Instructor III level. Candidates must demonstrate the knowledge and skills necessary to develop instruction materials and evaluation

instruments for fire courses. The course focuses on management and administration of training programs in addition to content and curriculum development. Candidates will be expected to perform instructional presentations to an audience, develop policies and procedures to guide training programs, and demonstrate appropriate management and administration of emergency service training programs. This course also prepares candidates to appropriately manage risk and plan and execute budgeting duties. Candidates should expect to spend a considerable amount of time outside of class to complete JPRs/ exercises and prepare for the written examinations. Students will be required to complete all assigned online learning modules prior to the start of the course.

IMPORTANT NOTE: The class includes just the Fire Instructor II written exam. You will need to schedule your Fire Instructor III exam after the conclusion of the class. JPRs are embedded in many learning activities and will be evaluated during the course. It is anticipated most students will complete all JPRs by the conclusion of the course and these JPRs will be evaluated by CDFPC proctors. Any unsatisfactory JPRs or JPRs not completed as pre-course assignments or during the course will be assigned to candidates as post course work.

**COST:** \$30 for the State Fire Instructor II written

exam.
