- 1. Approval of August 2013 minutes
 - a. Motion to approve minutes as submitted 1st O'Brien, 2nd Zader. Motion passed none opposed.
- 2. Banking changes are complete
 - a. Website renewed for 3 years. Cost: \$218.60/3 years. This is the non-profit rate.
 - b. Need to allocate \$2,500-\$5,000
 - i. F Koch met with BoCo Commissioners re funding on 9/5.
 - ii. Discussion in regards to future outlook in regards to funding the BCC if monies from the county decrease or aren't available.
 - iii. Discussion regarding allocating monies:
 - Motion to use the remaining 2013 money to purchase items off of the initial needs list and to update current equipment. 1st O'Donnell, 2nd Hise Motion passed – non-opposed.
 - 2. Discussion regarding items (i.e. pumps, saws) being used for incidents in addition to training.
 - 3. Course supplies will need to be updated at some point (ie. course guides)
 - 4. Suggesting to cut costs for fall classes.
 - a. Motion to decrease the cost of the fall classes to the following for the BCC (1) day class = \$50, multiple day classes = \$75. 1st Zader, 2nd O'Donnell.
 - b. Motion to spend the money (up to \$300) to buy/update course material for fall classes. 1st O'Brien, 2nd Hise. Motion passed none opposed
- 3. BoCo Grant/Commissioners update (Koch)
 - a. \$5000 for refreshers- updating/maintaining practice shelters.
 - b. 5000 for snap tank and (2) Mark 3
- 4. S230/231 Discussion for fall 2013
 - a. If we do a blended (online/classroom) class it would be a 2-day class and could be done on a weekend. Should we do both classes as blended or offer full or a combination thereof: discussion held.

- c. Group agreed to offer a blended 230 with a full 231. Students will need to do the online portions prior to the 3 days of class.
- 5. ENOP (engine op/wildland) class? D/O? (driver op structure) or D/O Pumper? (driver op pumper structure) (Fritz)
 - a. This would be a (5) day class students would need to bring an engine from their own agency for class.
 - b. Lyons FD has 3-6 interested in the DO/DOP class (per Chf. Hoffman)
 - c. The ENOP designation increases firefighter pay on wildland fires (approx. \$3/hr) This is not a requirement for ENGB or by NWCG.
 - d. Looking ahead (ENOP) discussion regarding scheduling and instructor needs/requirements.
 - i. Tentative plan to offer fall 2014.
 - ii. Suggestion to offer this every other year opposite of 230/231.
- 6. Any need for 130/190 field day?
 - a. Discussion regarding doing the course online and needing a field day.
 - b. Group agreed that a BCC endorsed field day is not an option. Agencies that choose to do the online portion will be responsible for providing their own field day.
 - c. Agencies may choose to coordinate their own field day outside of the BCC between agencies that have a need.
 - d. CWFIMA does offer a (1) day field day for S130/190
 - e. BCC will continue to provide and endorse a full 130/190 course each spring.
 - f. If agencies choose to do a field day BCC training equipment may be made available them Contact F Koch or R O'Donnell.
 - g. Reminder Firefighters need a red card and engines need to be properly staffed (per NWCG) for incidents that are Federal or outside of the home district.
