## **Program Overview**

Length: 64 hours (nights + weekends)

**Certification:** Boulder County Defensive Firefighter (DFF)

## **Requirements:**

• Completion of all 25 Exterior JPRs over 5 years to maintain currency

• Written Exam: 100 questions, 80% minimum passing

• Practical Exam: 9 mandatory JPRs + 4 random

**Exclusions:** Interior JPRs (Mayday, Search & Rescue, Exit Hazardous Environment, Vertical Ventilation, Interior Live Fire)

## **Key Job Performance Requirements (Exterior-Only)**

- PPE (don/doff, documentation)
- Communications (radio, telephone, incident response)
- SCBA (donning, emergency procedures no interior search)
- Ladders, forcible entry, utilities control
- Extinguishers, ropes & knots, hoisting tools
- Vehicle fires, Extrication, Class A exterior fires, ground fires
- Salvage, overhaul, scene lighting, air monitoring
- Water supply, hose handling, equipment maintenance

## **Utility Safety Integration (Xcel Modules 1–4)**

- Module 1: Electrical hazards & safe clearance
- Module 2: Natural gas response & shutoff procedures
- Module 3: Scene safety, downed lines, work zones
- Module 4: Joint operations with utilities, protective actions

#### Outcome

Graduates will be certified as Defensive (Exterior-Only) Firefighters, demonstrate all exterior JPRs under live-fire and scenario conditions, and be prepared for safe exterior suppression, support, and utility coordination roles.
