Training Offered

When Things Go Bad –

Wednesday 14th – Friday 16th – 24 hr class

Instructor – Paul Capo

Day 1 - In this full day of compelling training the student will have a complete understanding of the roles and responsibilities during a firefighter rescue regardless of your position. You will learn how to rescue other firefighters (R.I.T.) and also how to save your self (Firefighter Survival), by watching captivating live fatality vides and discussing case studies. S130/S190 –

Wednesday 14th – Friday 16th – 24 hr class

Instructor – Due to Wildfire season the Instructor is still to be named.

Day 1-3 - S-190 provides instruction in the primary factors affecting the start and spread of wildfire and recognition of potentially hazardous situations. S-190 is typically taught in conjunction with or prior to Basic Firefighter Training, S-130. It is designed to meet the fire behavior training needs of a firefighter type 2 (FFT2) on an incident as outlined in the PMS 310-1, Wildland Fire Qualification System Guide and the position task book developed for the position.

Shelter deployment and Arduous pack test will be included in the training.

Extrication w/ Heavy Lifting –

Thursday 15th – 8 hr class

Instructor – Byron Willems

Thursday - Some Extrication - But will concentrated on Lifting and Stabilization with Low Pressure Airbags, High Pressure Airbags, Mechanical lifting Struts and Hydraulic Lifting Struts. Basic Lift and securing a load and how this is affected your tools. How to teach multiple techniques for any scenario. Including most efficient, safest and quickest ways.

Paul Capo has been a firefighter since 1996 and serves as a Lieutenant/Paramedic in the Training Division with Clearwater Fire Rescue in Florida. Paul Capo is the Founder of, When Things Go Bad, incorporated where he develops a vast compliment of firefighter curriculum and training. His diverse teaching includes, but not limited to, FDIC (Fire Department Instructors Conference), Fire House Expo, Orlando Fire Conference, Fire Rescue East, Wichita HOT, etc. where he trains on multiple subjects in fire service academia. Paul is considered by many to be one of the nation's leader's in the "new vanguard" of Firefighter Rescue / Rapid Intervention Crew capabilities. He and his crew can be seen regularly on Fire Engineering's Training Minutes as well as in the When Things Go Bad's training DVD series. In addition, he frequently instructs and consults in areas of firefighter self preservation – the physiological changes during firefighter survival. Paul has achieved his B.A.S. in Public Safety Administration and is an instructor at Saint Petersburg Fire College where he teaches all levels and topics of firefighting.

Physiology of Self Preservation

During survival stress, hormonal induced tachycardia will overwhelm you; your fine and complex motor skills as well as your rational thinking will not be active without the

proper training. Through case studies and documented research, I will discuss how we can train our midbrain for success when we feel death is imminent.

As our industry is training more on Firefighter Rescue, we have to ask ourselves, are we training the right way? Do you know what you will experience or be capable of accomplishing when you feel that yourself or a fellow brother or sister firefighter is going to die?

Deadly encounters in the arenas of law enforcement, special ops, and firefighting, which branched out to other disciplines, have provided data that explains how the body reacts in a predictable manner when we are under Survival Stress no matter what the environment! This program discusses the difference between physical tachycardia and hormonal induced tachycardia. Many of us focus on our physical health, being that's the leader of fatality in our industry, but how many training organizations neglect the presence of our hormonal or fear induced tachycardia (fight/flight).

All of these psychological and physiological responses are concluded with training tactics needed to overcome and/or manage them in the time of need. With stress inoculation of the midbrain we learn how to prepare for the worst day in any firefighter's life. Stressed firefighters will only do what they're trained to do. You do not rise to the occasion, you sink to the level of your training.

This compelling program ties all studies together with all traditional R.I.T and Survival drills (Ex. Entanglement, bail-out, breaching, Nance, packaging, etc.) I will explain how we

2-day Hands-On Course

This dynamic 2-day hands-on course will consist of 1-day of Firefighter Rescue (RIT) techniques followed by 1-day of Firefighter Survival; all ending in a comprehensive scenario. It is not enough to be aware of the skills that are needed to be performed, true competency come from realistic hands-on training. In this high speed, When Things Go Bad training the student will learn; *Assessment of a downed firefighter, Air management, Packaging, Drags, Window lifts, Ladder carries, Up/down stairs, Hauling a firefighter, Deploying in as a RIT team, Roof removals, Wall breaching, the Naked SCBA drill, Reading Couplings, MAYDAY transmission, Disentanglement, Headfirst ladder bailouts, and Rope slide.* After this course, the student will be confident in multiple situations in which to rescue them-



County Fire Tactics

Wednesday—Friday June 14-16

Instructor—Curt Isakson

Curt Isakson is a 27 year veteran of the fire service. Curt is currently a Battalion Chief for Escambia County Fire Rescue. Previously worked 9 years with the Pensacola Fire Department where he was assigned as the Company Officer on Rescue 31. Curt's fire service experiences started at a young age as a Junior firefighter with the Midway Fire Protection District and rose through the ranks to Captain. He has worked in volunteer, career, and combination departments.

Curt has held all ranks up to Battalion Chief and been assigned to operations, training, inspections, and was Chief of Special Operations for 7 years. Curt owns and operates County Fire Tactics that covers a very diverse range of fire service topics, as well as Firefighter Rescues, a site that documents rescues made by firefighters around the country.

He has annual contracts with numerous departments to provide standardized monthly training for these departments that respond daily together under an automatic aid agreement. Curt teaches nationally to include; FDIC, Firehouse Expo, Firehouse World, Orlando Fire Conference, Atlanta Fire Conference, Bowling Green State University, and owns/operates the annual HROC on Pensacola Beach.

He is a Florida certified Fire Officer, Fire Instructor, Arson Investigator, and Urban Search & Rescue.

We will NOT HAVE LIVE FIRE. We will cover solid Fire-ground Tactics taught by Instructors with a solid foundation and experience on the Fireground.

Stretching & Operating the first three lines

Weapon Selection and how to do a department nozzle evaluation

RIT Operations and Survival to include Rope Searches.

S-130 is designed to provide entry level firefighter skills. Many of the units are set up so they can be taught in either the classroom or the field; field time is encouraged. A version of L-180, Human Factors on the Fireline and I-100, Introduction to ICS has been included as part of this course. Credit is issued for S-130, S-190, L-180, and I-100 upon completion of this course. S-190 provides instruction in the primary factors affecting the start and spread of wildfire and recognition of potentially hazardous situations. S-190 is typically taught in conjunction with or prior to Basic Firefighter Training, S-130. It is designed to meet the fire behavior training needs of a firefighter type 2 (FFT2) on an incident as outlined in the PMS 310-1, Wildland Fire Qualification System Guide and the position task book developed for the position.
