S-320 Introduction to Incident Management Teams

Instructor led portion to be held at the Truckee Meadows Community College Redfield Campus, 18600 Wedge Parkway, Building B Reno, Nevada.

Selected students will need to complete the self-paced online training and pass an assessment before attending the instructor led course.

DESCRIPTION:

S-320 is designed to introduce students to the knowledge and concepts required to understand and engage as part of an Incident Management Team (IMT). The instructor led portion provides scenario based activities that allow participants to apply these knowledge and concepts required to meet the responsibilities of an IMT member.

This offering of S-320 is likely the final test session of course materials that are intended to become a requirement for certification in all Type 3 Command and General Staff positions in the future. Students who complete the course will receive full credit for S-320 and will not have to repeat the course once the course is approved by NWCG. This is a rare opportunity as a student to provide feedback at the ground level for a course that will be used to shape the Incident Management Teams of the future. Instructors for the course serve on local Type 3 Incident Management Teams and represent the different functional areas within teams.

TARGET GROUP:

Any individuals desiring to serve on incident management teams in all Type 3 Command and General Staff positions including those desiring to be certified as Type 3 Incident Commanders.

Prerequisites:

Completion of the online portion (6-8 hours), passing grade on the assessment, ICS100, and IS700

OBJECTIVES:

- Practice performing functional area responsibilities to effectively execute the incident planning process.
- Given a scenario engage in an efficient team process that achieves the direction given by the Agency Administrator.
- Participate in the incident planning process for a level appropriate scenario.
- Participate in the strategic planning process by engaging in values-based decision-making processes and providing situational awareness and strategic assessment updates.
- Engage in values based strategic analysis to evaluate and present alternatives and rationale to achieve incident objectives.
- Practice conveying command presence and leader's intent.
